In the context of Covid-19 pandemic, the school has already allowed concession to the extent of enhancement of fee made during the year 2020-21 over the fee of the previous year (2019-20) vide notice No.DAV(PKT)/1170/2020 dated 13.07.2020. Further, in pursuance of the orders of the Hon'ble High Court dated 7 January 2021, Govt. notification dated 19 January 2021 and orders passed by the Hon'ble Supreme Court in SLP(C) No.3355/2021 dated 18/03/2021 the school has allowed additional concessions vide Notice No.DAV(PKT)/518/2021 dated 20/03/2021. The school has once again considered the issue in the context of the orders passed by the Hon'ble Supreme Court dated 03/05/2021 and subsequent notification No.10215/ SME dated 03/06/2021 of School and Mass Education Department, Govt. of Odisha and has now decided to allow the fee concession for the year 2020-21 as follows and if as a result any refund/adjustment is due, it will be adjusted against the school fee of 2021-22 in  $\frac{4}{12}$  equal instalments deducting from the quarterly fees payable for each quarter:
