- The classes will remain suspended till the beginning of the New Session-2020-21.
- The date of commencement of the New Session -2020-21 for **Class-XII** will be informed through notice to be published on the School Notice Board and Website.

- Students placed under compartmental are required to appear the Compartmental examination as per the schedule given below. Failure in compartmental subject will lead to failure in Class-XI and under no circumstances their case for re-examination will be considered.

- Failure in the Compartmental subject will lead to failure in Class XI and under no circumstances their cases for re-examination will be considered by the Regional Director/School.

- If any candidate desires to have any of his/her answer scripts rechecked has to follow the following rules prescribed by the Regional Directorate, DAV Institutions, Odisha, Zone-1.

i) A candidate who has appeared the Annual Examination 2020 conducted by the Regional Directorate may apply for verification of marks in any particular subject

Verification of answer scripts means verification of the following:

- (a) Verification of un-assessed /unevaluated portion if any.
- (b) Verification of addition of total marks,
- (c) Verification of correct transfer of marks to Title Page and Award List.
- (d) Verification of stitching of Additional Sheet (s) if any.
- (e) No revaluation of Answer script /additional sheet shall be made as per the rules.

ii) Application for verification of marks must be made within **10** days from the date of the declaration of result i.e. **by 27/03/2020 using Proforma (.MV-1) at the School Reception Counter.**

iii) All such application must be accompanied with D.D. of **Rs.100/-** per subject towards the verification fee, to be drawn in favour of Regional Officer, DAV institutions, Odisha, Zone- 1, payable at Bhubaneswar.

iv) If the mark of any students is changed after verification , the amount deposited shall be refunded.

v) If any error in evaluation is found at the end of the system, the amount deposited for the purpose will be refunded on application.

vi) In no case the verification of Marks shall be done in the presence of the candidate or anyone else on his/her behalf, nor will the answer books be shown to him/her or his /her representative.

vii) The marks on verification will be revised upwards or downward, as per the actual marks obtained by the candidate in his/her answer book.

(viii) The communication regarding the revision of the marks if any, shall be sent to the candidate through concerned school.

(ix) The Regional Directorate will not be held responsible for any loss or damage or any inconvenience caused to the candidate, consequent on the revision of marks or delay in communications for reasons beyond control.

- (x) The Regional Directorate shall revise the Marks statement in respect of such candidates even if the previous marks statement is not returned by the candidate.
- (xi) The decision of the Regional Director on the result of the verification of marks shall be final and binding.
- Parents interested to collect Transfer Certificate (T.C.) of their ward(s) may apply in the prescribed format available in School office on or before **24 March 2020** and it should be collected before **31 March 2020** positively otherwise fee due shall be charged.
 - The fee Structure as finalized by PTCC meeting held on **02/02/2020** and duly approved by the School Managing Committee on **25/02/2020** is given below.

- As per the direction of DAV CMC & CBSE the school has implemented “**Non-Cash mode of On line school fees payment**” through Debit Card, Credit Card, Net Banking facility of any bank. The parents choosing online payment are required to visit school website www.davpkt.org.in and click on “**PARENTS LOGIN**” for necessary instruction to this regard. By default the School No/Admission No of your student has been taken as both User ID and Password. Parents can also modify the password as per their suitability. The first quarter School Fee shall be paid on or before **25 April 2020**.
- In order to provide better bus facilities it has been decided that the students should exercise their option for availing the facilities at the beginning of the academic session with full payment.. Therefore, the interested students are requested to collect the **prescribed format & Pay-in-slip** (pink coloured slip) available in the reception counter of the school from **23rd March 2020**. Kindly deposit the required amount in Bank counter and submit the registration form in school office furnishing the needed information therein by **31st March 2020**. There is no provision of installment payment of bus fee for this session(2019-20). Under no circumstances the bus fee once paid **can be refunded or adjusted** against any other fee if the child discontinues the facility or leaves the school.
