NOTICE

As per the notification of the CBSE vide no. COORD/PRINTING/2020 Dated. 02.06.2020 , CBSE is going to conduct the remaining Class XII Board Examination-2020 from 01.07.2020 to 15.07.2020 because of the prevailing condition of spread of COVID -19 pandemic in the country. Special efforts has been taken by the Board for conducting the examinations in a safe manner . The following decisions have been taken by the CBSE for smooth conduct of remaining examinations in different subjects .

1. Examinations for the subjects Business Studies (054) and Computer Science (283) (Old) would now be conducted in our school for our school students instead of the Examination Centre already allotted.
2. CBSE has allowed the change of examination Centre in respect of candidates who have shifted and residing in some other districts in the country from the place of their school.

Keeping in view of the notification of the CBSE , the regular candidates for the subjects Business Studies (054) and Computer Science (283) (Old) are urgently required to give in writing and requesting there in for change of examination centre directly to the school on or before 09.06.2020 if they have shifted from the khordha district to some other State/ District within India. If no request will be received by 09.06.2020 from any candidate , it will be presumed that they will appear the Board Examination in our school itself as per the exam schedule.

Following category of regular candidates for the Subjects Business Studies (054) and Computer Science (283) (Old) will be eligible to make request for change of examination centre.

- i) Students who were residing in hostel.
- ii) Students sponsored by State Governments.
- iii) Students who have shifted from the district of their school to some other district within India.

No request for change of examination Centre should be sent to CBSE directly by the candidates. Such requests will not be entertained by the CBSE. So all the candidates will apply immediately i.e. on or before 09.06.2020 to the school authority in case they desire to change their examination centre to their present district where he/she is now residing.
